Listed below are the RULES that must be followed for the upcoming election:

1. To be eligible to run for national office in the Women's Council, a person must be a Member of the Women's Council and financial for the **past three (3) years**.
2. To be eligible to vote, membership status must be current by **June 30, 2026**.
3. All candidates must submit to the Nominating Committee a signed recommendation letter from the local chapter president. If there is no existing chapter in your city/state, you must submit a letter from the local NAREB Board President of State President.
4. Candidates must submit one (1) copy of their resume.
5. Candidates must submit their position they are interested in and state why they are interested in running for the position.
6. Each candidate will make a presentation of three (3) minutes or less at the interview. The interview date and time will be submitted to each applicant.
7. Please be sure to wear red attire and your lapel pin for the interview.
8. Nominations may be taken from the floor for the position of President only if the nominee has served in the most recent administration.
9. The nominations will be posted near the Convention Registration area in a conspicuous place and on the Women's Council website 24 hours prior to the election.
10. Any person serving on the nominating committee is not eligible to run for office.
